Terms & Conditions

1. Duration of the competition

(Hereinafter referred to as the "Draw" and "Contest Period").

2. General conditions of participation

Only legal persons over the age of 18 years who have some form of statutory photo identification such as a passport at the time of the competition may enter the draw. By participating in the Draw, contestants confirm they accept and are fully acquainted with the contents of these terms and conditions, including any changes, applicable regulations and/or additional Draw terms and conditions that may reasonably be published as updates from time to time during the Contest Period.

3. Competition Procedure(s)

4. Draw & Prize

Date of draw will be at 10:00am CET on the 10th March 2017 at the offices of the organiser. Entries submitted after the Contest Period will not count and shall be excluded.

5. Winner Notification
